Highlights:

- Adult Clinical Neuropsychology in Woodley Park (across from the National Zoo, Redline Metrostop)
- Outpatient neuropsychological assessment under the supervision of a board certified clinical neuropsychologist
- Assessments focus on various neurocognitive disorders, some of the more frequent include:
 - Dementia
 - Stroke
 - TBI
 - ADHD/LD
 - Autism
 - ID
 - Schizophrenia
- Assessment types include:
 - NFL Baseline Assessment Protocol (BAP)
 - INE/IME – Independent Medical Evaluations for determination of continuation of disability insurance
 - Referral from behavioral health providers for helping with their treatment plans
 - Guardianship - Competency to manage finances
 - Forensic Assessment including pre-trial competency & criminal responsibility, and, post-trial aid in sentencing
 - Civil litigation related to malpractice and personal injury
 - Self-referral with varied symptom presentation

This externship will provide the student with an inside look at how a private practice in clinical neuropsychology works. The student will learn how to evaluate many different types of patients and write different kinds of reports to include both clinical and forensic. Clinical interviews will be conducted with the supervisor. Testing will occur mostly on Fridays with the possibility of other days/times. Report writing can be done remotely.
